All articles will be indexed in the RSCI system.** Conference participants will be awarded certificates. Working languages of the conference are Russian and English.

## ARTICLE REQUIREMENTS

**Number of authors:** no more than 4.

**Article length:** from 3 to 6 pages of typewritten text.

**Relevance.** Article should be written on an essential subject and contain the results of a comprehensive personal research.

**Plagiarism check.** Originality of the text should be no less than 70 %.

**Responsibility.** Participants of the international conference bear full responsibility for authenticity and validity of the information. It is necessary to add the copyright symbol (©) with the author's name and current year at the end of the article.

**Page setup.** Page size A4 (210×297); portrait layout. Pages should be left unnumbered. Margins (upper, lower, left, and right) are 20 mm each. Fontis Times New Roman, 14 size. Line spacing is 1.5. In terms of alignment, text should be fully justified.

### **Article composition in order:**

1. Full names of the authors in English.
2. Place of work/education, city in English.
3. E-mail of the author responsible for communication.
4. Title of the work in English (uppercase).
5. Abstract in English, not exceeding 600 symbols in length.
6. Keywords (no more than 7).
7. Items 1, 2, 4, 5, 6 in Russian
8. Text of the article.
9. References.
10. Date of the submission.
11. Copyright symbol (©) with the author's name and current year.

Units of measurement are given according to the International System of Units (SI). Abbreviations of words, proper names, etc. are not allowed, except for generally accepted. All abbreviations and acronyms should be expanded at the first usage.

**Figures and tables.** All images used in the article (including graphs) should be submitted in the jpg, gif, or bmp format; illustrations created using MS Word and MS Excel tools will not be accepted. Figures and graphs (preferably monochrome, because the printed version of the Proceedings will be published in black and white, and only the digital version will feature the original color scheme) should be perfectly legible and of high quality; they are placed in the text. Tables and figures requiring the landscape page layout are not allowed. Numbers and titles of the figures should be given under the respective figure, and those of tables should be given above the respective table. All tables, figures and graphs should be mentioned and directly referenced in the text.

**List of references.** The literature sources referenced in the text are presented after the conclusion under the subtitle "References". The list of references is arranged in the alphabetical order: the sources which titles are initially written in Cyrillic letters are placed first (with both transliteration and translation), then the sources in English (using the Latin alphabet) are listed. In the text, the reference is designated with the due number enclosed in square brackets, e. g. [3]. The reference in the list should contain all generally required components:
